We are now seeking interest from experienced and successful environment project officers who are ready for a new and exciting challenge. Based within the iconic landscapes of the southern Lake District this role will commence in summer 2020.

This is a unique opportunity to work alongside United Utilities, the UK's largest water company and allow you to combine an understanding of diffuse water pollution, habitat improvement, river restoration and natural flood management techniques to help safeguard the provision of clean drinking water for the communities of South Cumbria. This will require a close working relationship with United Utilities who you will assist to deliver Drinking Water Safety Plan actions. This will include reporting at various levels and providing evidence for the improvements that are being achieved.

Reporting to SCRT's Team Manager and working alongside a great team of dedicated individuals within the Trust and supported by our project partner, United Utilities, you will be responsible for a four year programme of investigation and practical works that will contribute to improving raw water quality in three specific south Cumbrian catchments.

Your work will involve identifying sources of diffuse water pollution and poor land management practices that may impact on the raw water quality of the watercourses in your work area. Through this understanding of sources and pathways you will build a detailed

record of these catchments leading to the identification, scoping and promotion of potential interventions. You will then lead on all aspects of projects approved for delivery including monitoring and reporting.

This role requires an energetic and multi-talented individual who is a self-starter and results focussed. You will be a natural communicator who can form and establish great partnerships at all levels and has a proven record of securing agreements with landowners and farmers.

Knowledge and proven experience of practical river conservation work, river catchment and land management issues and a broad understanding of the legislation that underpins these activities is essential.
